As announced in the March 2019 Issue of the Bulletin, SafeISBA has transitioned to the Professional Conduct Committee (see https://bayesian.org/membership/safe-isba/). Earlier this year the Board also approved a major update of the Code of Conduct and Procedures. The Code of Conduct comprises policies on Ethics, Equal Opportunity and Anti-Harrassment. The SafeISBA Task Team with support from the Board was instrumental in developing and implementing the Code of Conduct, and also in carrying out the recent revisions based on feedback received from our community during a three month period as a result of a call for comments sent out to all ISBA members in May 2018. Once again, I want to thank the members of the SafeISBA task team and all our Board members last year and this year for their work. This has been a long and difficult process, but we have made significant progress in creating a set of rules and procedures that will make our society safer. The newly formed Professional Conduct Committee is now responsible for administering the Code of Conduct and Procedures. Furthermore, this Committee will consider further revisions in the coming months and will bring those to the attention of the Board by the end of the summer. I will be informing you about this process as soon as it is completed.

The 2020 ISBA World Meeting will be held June 29-July 3, 2020 at Kunming, China, hosted by Yunnan University. Information about the meeting will be added to the conference website http://www.isba2020worldmeeting.com as it becomes available. The Committee on Named Lectures has selected Jim Berger as the Bruno de Finetti Lecturer and Tamara Broderick the Susie Bayarri Lecturer. The Keynote Lecturers are Ismael Castillo, Leonhard Held, Amy Herring, and Suchi Saria. The Foundational Lecturers are Wesley Johnson, Helene Massam, Xiao-Li Meng, and Fernando Quintana.

The nine sections of ISBA have each solicited proposals for Invited Sessions in the months of April and May 2019. The final decision on the Invited Sessions will be announced by July 5, 2019. In mid June 2019, a public call for Member Invited Session (MIS) proposals will be sent to all ISBA members. The submission link for proposals will be provided in the announcement and will also be added to the conference website. MIS proposals will be due three weeks after JSM, on August 22, 2019. After that, an open call for Contributed Talks will be sent out in early September.

The Savage Award, named in honor of Leonard J. "Jimmie" Savage, is bestowed each year to two outstanding doctoral dissertations in Bayesian econometrics and statistics, one each in Theory & Methods and Applied Methodology. Finalists will be notified in December 2019 and invited to present their dissertation research in a special contributed session at the ISBA World Meeting, in Kunming, China, in 2020.

The Mitchell Prize is given in recognition of an outstanding paper that describes how a Bayesian analysis has solved an important applied problem. Workshop on Risk Analysis for Extremes in the Earth System will be held in Berkeley, CA, from July 22–24, 2019. See information at: https://cascade.lbl.gov/upcoming-workshops-conferences/

The Workshop on Risk Analysis for Extremes in the Earth System will be held at the Lawrence Berkeley National Lab in Berkeley, CA on July 22 - 24, 2019. This workshop will serve two complementary purposes. The first is to introduce graduate students, as well as others wishing to enter into the area

of extreme value analysis, to the techniques and challenges that are unique to studying rare events. The second is to provide a venue for statisticians and Earth scientists to share ideas and facilitate collaboration aimed at understanding rare, high-impact events in the Earth system.

The first day of the workshop will feature a pair of short courses, one on contemporary advances in statistical analysis of extreme events, and the second on using the NIMBLE and climextRemes software for data analysis. The following two days will feature research talks on statistical methodology and applications related to extremes, as well as talks on the science and impacts of extreme events in the Earth system. These talks will include several by researchers in both statistics and fields related to Earth science. Finally, there will be a poster session on the evening of Tuesday, July 23.
