Also, as I have mentioned before, the 2022 ISBA World Meeting will take place in Montreal, Canada. We expect to sign the agreement with the hotel that will host the conference by the end of this year. We should have more news about this very soon.

I also want to give you an update about some recent changes that have been made to the Code of Conduct (CoC) Procedures and FAQs, and to Section F.5 of the ISBA Bylaws. The current versions of these documents available online at https://bayesian.org already reflect these changes. Regarding the CoC Procedures, the following changes were approved recently by the ISBA Board:

- 1. Additional language that clarifies conflict of interests was added to Page 1.
- 2. Requirement of a mail notification via certified mail when providing notices to members that may be contacted as part of a conduct review. This requirement was added to Page 2.
- 3. A statement about intentional false accusations or defense was added on Page 3.

The CoC FAQs document was also updated to include a question that explains how ISBA deals with

# UPDATES FROM BA

### From the BA Editor - Michele Guindanimicheleguindani@gmail.com

There is a lot of news to share with the Bayesian community in the last quarter of 2019! Let me start with the most recent one. Following extensive input, the **Australian Business Deans Council** (ABDC) has recently upgraded our journal to Rank A. This is terrific news, which recognizes the long-time work of our authors and editors over many years, and the appreciation of our readership. Thanks to everyone who has contributed their input to inform the ABDC ranking!

The **December issue** of the journal contains the manuscripts competing for the **Lindley Prize**. The Lindley Prize is awarded for innovative and original research in Bayesian Statistics that was presented at the 2018 ISBA World Meeting in Edinburgh and that has been accepted for publication in *Bayesian Analysis*. The Prize recognizes the impact and importance of Lindley's work in the foundations, theory, and application of Bayesian Statistics. We have 12 excellent manuscripts competing in this round, which have made the work of the evaluation committee particularly challenging. As per tradition, the Lindley Prize Committee and the winning manuscript will be announced at the 2020 ISBA World Meeting in Kunming, Yunnan, China.

Mark your calendars! *Bayesian Analysis* will present an invited session at the **ISBA 2020 World Meeting**, on "Inference in Graphical Models and Networks" with Yuguo Chen (University of Illinois Urbana Champaign), Jami Jackson Mulgrave (Columbia University) and Jian Kang (University of Michigan) as invited speakers, followed by a discussion. The session is tentatively set for Wednesday July 1st, 2020.

*Bayesian Analysis* will also present an invited session on "Highlights from *Bayesian Analysis*: Bayesian methods for the public good" at the **2020 Joint Statistical Meetings** in Philadelphia. The session is currenly scheduled on Monday, 8/3/2020 at 2:00 PM, with presentations by Simon E. F. Spencer (University of Warwick, UK), Zehang Richard Li (Yale School of Public Health), Jarno Vanhatalo (University of Helsinki, Finland), and Kurtis Shuler (University of California Santa Cruz).

During the past quarter, we have started a series of journal **Webinars** to highlight significant contributions to the journal. The first two Webinars have presented the manuscripts selected as Discussion papers in the 2019 September and December issues. The Webinars are now available on the **Bayesian Analysis YouTube Channel**, and they are also directly linked from the online abstract of each manuscript. New initiatives have been planned for the new year. Please, stay tuned to our mailing lists and the ISBA social networks for more details.

As previously announced, Jin Cao (SMU) has agreed to hold the position of Managing Editor of the journal from January 1st, 2020 to December 31st, 2022. She will help to ensure a smooth and fast reviewing process. I want to thank Tony Pourmohamad (Genentech, Inc) for his valuable help over the past three years. In addition, Eloise Kaizar (Ohio State University), Fabrizio Leisen (University of Kent, UK), Ioanna Manolopoulou (University College London & Alan Turing Institute), and Xinyi Xu (Ohio State University) will join the Editorial Board of Bayesian Analysis as Associate Editors starting January 1st, 2020. I take the opportunity to send a big thanks to them and to all the members of the Editorial Board for their dedicated commitment to the success of the journal!

Finally, we now welcome public contributions to the Discussion of the manuscript: "A Novel Algorithmic Approach to Bayesian Logic Regression" by Aliaksandr Hubin, Geir Storvik, and Florian Frommlet, which will be featured as a **Discussion Paper for the March 2020 issue** of the journal. You can find the manuscript in the Advance publication section of the journal website. The contributions should be no more than two pages in length, using the BA latex style. The contributions should be submitted to the journal using the Electronic Journal Management System (EJMS) submission page, before **February 1st, 2020**.

optimal processing of information from different sources, efficient forecasting using sets of models, and measuring policy effectiveness and its associated risk.

Their aim is to bring together researchers and professionals interested in the application of Bayesian inference in economics in relatively small annual workshops that usually take two days. Please, note that a moderated, low-frequency mailing list related to Bayesian econometrics and the application of Bayesian statistics in economics, finance, and business has been created. The **Bayesian Young Statisticians Meeting** will be held on June, 26-27 in Kunming, China. BAYSM is dedicated to Ph.D. students, M.S. students, post-docs and young researchers working in the field of Bayesian statistics. BAYSM is an opportunity to connect with the Bayesian community at large, to exchange ideas, and to know people working in the same field for creating future networks. The presence of a senior discussant in each session will allow participants to get advice and comments to their current research.
